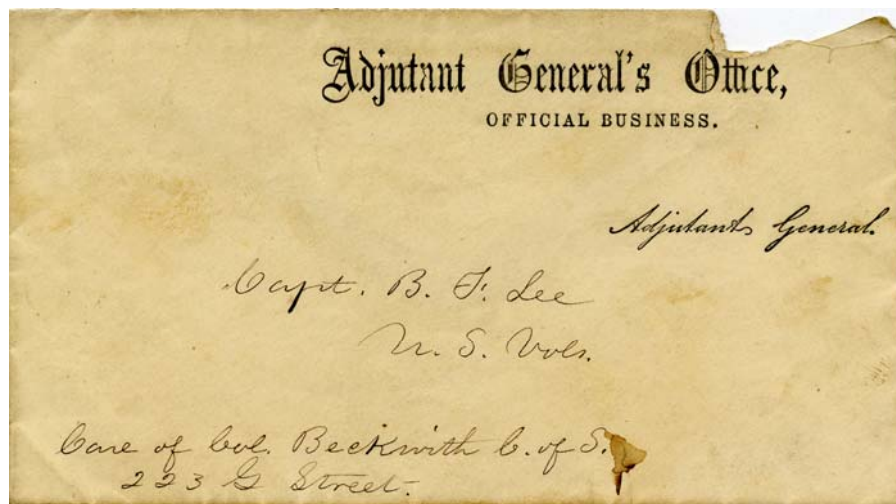

### **Biography:**

Benjamin F. Lee was mustered into service on June 28, 1861 as Quartermaster for the 28<sup>th</sup> Pennsylvania Infantry. He remained in that position until September 18, 1862. At that time he resigned to accept a commission as Captain and A.C.S, [Adjutant Commissar of Subsistence]. He remained in the service for three years. After the war, Benjamin F. Lee was the personal secretary to his brother-in-law and former Colonel, Pennsylvania Governor John W. Geary.
